INSTRUCTIONS INSTRUCTIONS FOR INVESTORS

- 1) Application Forms must be completed in **BLOCK LETTERS IN ENGLISH.** A blank space must be left between two or more parts of the name.
- 2) Minimum investment-2 Bonds of Rs. 10,000/- each and maximum investment-500 Bonds amounting to Rs. 50 lakhs in a financial year.
- a) Investors are required to submit the duly filled in Application Form along with necessary enclosures at the designated branches of collecting banks-HDFC Bank, Indusind Bank, YES Bank, ICICI Bank or Kotak Mahindra Bank Ltd. Demand Draft or account payee Cheque should be drawn in favour of "PFC Capital Gain Bonds". UTR details, if applicable, must be mentioned in the box appearing in overleaf.
 - b) For details of designated bank branches, please refer Information Memorandum (IM) or visit our website: www.pfcindia.com.
