



Eligibility criteria for listing on NSE Emerge Platform

The following criteria should be complied with as on the date of filing the Public Offer Document with NSE as well as when the same is filed with RoC & SEBI.

Parameter	Listing Criterion
Incorporation	The Issuer should be a company incorporated under the Companies Act 1956 / 2013 in India.
Post Issue paid up Capital	The post issue paid up capital of the company (face value) shall not be more than Rs. 25 crore.
Track record	Track record of atleast three years of either the applicant seeking listing; or the promoters****/promoting company, incorporated in or outside India or Partnership firm & subsequently converted into a Company (not in existence as a Company for three years) & approaches the Exchange for listing. ****Promoters mean one or more persons with minimum 3 years of experience in the same line of business & shall be holding at least 20% of the post issue equity share capital individually or severally The company/entity should have positive cash accruals (earnings before depreciation & tax) from operations for atleast 2 financial years preceding the application & its net-worth should be positive.
Other Listing conditions	The applicant Company has not been referred to Board for Industrial & Financial Reconstruction (BIFR). No petition for winding up is admitted by a Court of competent jurisdiction against the applicant Company. No material regulatory or disciplinary action by a stock exchange or regulatory authority in the past three years against the applicant company.
Disclosures	The following matters should be disclosed in the offer document: Any material regulatory or disciplinary action by a stock exchange or regulatory authority in the past one year in respect of promoters/promoting company(ies), group companies, companies promoted by the promoters/promoting company(ies) of the applicant company. Defaults in respect of payment of interest &/or principal to the debenture/bond/ fixed deposit holders, banks, FIs by the applicant, promoters/promoting company(ies), group companies, companies promoted by the promoters/promoting company(ies) during the past three years. An auditor's certificate shall also be provided by the issuer to the exchange, in this regard. The applicant, promoters/promoting company(ies), group companies, companies promoted by the promoters/promoting company(ies) litigation record, the nature of litigation, & status of litigation. In respect of the track record of the directors, the status of criminal cases filed or nature of the investigation being undertaken with regard to alleged commission of any offence by any of its directors & its effect on the business of the company, where all or any of the directors of issuer have or has been charge-sheeted with serious crimes like murder, forgery, economic offences etc.
